

Application Living allowance Ukrainian displaced persons

What is important to know with regard to this application?

- You must be registered in the Personal Records Database (Basisregistratie Personen, BRP) of the Municipality of Haarlem.
- You must have a bank account number in the Netherlands. Or you
 have an account number abroad and can use it in the Netherlands.
- You can apply for a living allowance if you are residing in the reception area or with someone at their home address.
- The living allowance is intended for food, personal expenses and your stay at someone's home address.
- You are not entitled to the living allowance if you have Dutch nationality. In that case, you should apply for a living allowance at the Sociale Verzekeringsbank (SVB).
- Do you have any questions? Send an e-mail to <u>leefgeld@haarlem.nl</u> You cannot forward the application via e-mail.
- Do you plan to move within Haarlem or to another municipality? Notify the municipal Civil Affairs Department of this.

What must you submit with this application?

- The form: fully completed and signed
- Copy of your bank card or bank statement indicating the number at which you wish to receive the living allowance.
- Copy of your proof of identity, including that of your partner and children, if applicable.

Note: You could possibly receive the living allowance before receiving an official decision. Keep a close eye on your bank account. The decision will arrive at a later stage.
